

## American Avalanche Association Prior Learning Assessment

The American Avalanche Association acknowledges that many professionals are currently engaged in or have completed training under the previous education system. Our goal is to engage professionals at their current level in the previous educational system, provide clear direction on how to proceed, and promote consistency in training.

\*Bridge course evaluating student's skills from the previous Level 2 training will be offered for the first three years of the new professional avalanche training program. Following the first three years of the new program, a student with a Level 2 completion from the old educational system will need to take the complete Pro 1 course.

\*\*Pro 2 avalanche training contains material not covered in the previous level 3 courses; however, expectations are that, post level 3 or AVPRO, professionals continue to acquire skills through continuing education and on the job training. This course needs to have been completed no earlier than 2005.

### **Recognition of Equivalency:**

American Avalanche Association does not issue equivalency certificates. In collaboration with Course Providers, it was agreed upon that the chart (Table 1) will be used to determine current level of training. Please use this chart should you need recognition of equivalency for employment.

If you believe you meet the qualifications for equivalency and would like to take subsequent Pro courses, it is the responsibility of the applicant to demonstrate that he/she meets or exceeds the skills and proficiencies described in the Pro 1 or Pro 2 Proficiencies and Guidelines documents. It is encouraged that the applicant take the time to compile a complete, thorough, and concise application with clear evidence supporting his/her claim for equivalency. Prior Learning Assessment applications should be submitted to the Course Provider with whom you wish to take a course. Assessments will be reviewed by the Course Provider to determine eligibility for the next course.
